

Win a Wedding Contest – Official Rules & Judging Criteria

(Sponsored by Wed&Done)

1. Contest Overview

The **Win a Wedding Contest** is a skill-based competition where engaged couples submit an entry showcasing their love story and vision for their Arizona dream wedding. A panel of judges will evaluate submissions based on predetermined criteria to determine the winner. The winning couple will receive one of 5 wedding package tiers, facilitated by **Wed&Done**.

By entering, contestants agree to abide by these official rules. This contest is **not a game of chance**, lottery, or sweepstakes—it is a **competition based on skill**.

2. Eligibility

- Open to **engaged couples** who are **18 years or older** at the time of entry.
 - U.S. residents only.
 - Participants must be legally able to marry and agree to wed within 18 months of winning.
 - All of the wedding packages will take place in Arizona. The winning package is not transferable to any venues or wedding gown shops outside of Arizona.
 - For \$2500 Magical Wedding Planning Prize - the venue must be within 50 miles of the greater Phoenix area.
 - Employees of **Wed&Done**, contest judges, and their immediate family members are **not eligible** to participate.

3. How to Enter

- **Entry Fee:** A non-refundable fee of **\$20 (plus taxes and credit card fees)** is required per entry.
- **Submission Requirements:**
 - A **video, written essay, or photo story** explaining:
 1. **Your Love Story** – How you met, details about your unique story, and why you should win.
 2. **Your Dream Wedding Vision** – Why an Arizona wedding is perfect for you.

3. **Creativity & Personality** – Make your entry unique!

- **Submission Deadline:** All entries must be received by **5/06/2025** at **11:59 PM PST**.

4. Judging Criteria

A panel of **industry professionals** will evaluate entries based on the following **100-point scale**:

- ✓ **Originality & Creativity (40 points)** – Is the submission unique, engaging, and heartfelt?
- ✓ **Storytelling & Personalization (30 points)** – How well does the couple convey their love story and wedding vision?
- ✓ **Clarity & Presentation (20 points)** – Is the submission well-organized and thoughtfully crafted?
- ✓ **Relevance to Arizona Wedding Theme (10 points)** – How well does the couple connect their vision to a wedding in Arizona?

The couple with the highest overall score will be selected as the winner. In the event of a tie, judges will deliberate and determine the final winner based on **originality and storytelling strength**.

5. Winner Selection & Notification

- The winner will be notified via **email and phone** on **5/13/2025**.
 - If the winner does not respond within **48 hours**, an alternate winner may be selected.
 - The winning couple **must sign an agreement** confirming their participation and acceptance of the wedding package terms.

6. Event Eligibility, Prize Details & Forfeiture

- The **Grand Prize** consists of a **wedding package valued at \$30,000**, including the couple's choice of a Wed&Done venue. The package also includes the following Wed&Done vendors - catering, photography, DJ, dessert, and floral arrangements. Upon winning one of the wedding packages (either for \$10,000, \$20,000 or \$30,000) the couple will have access to the Wed&Done Magical path, where they can customize their wedding package.

- The awarded wedding package is non-transferable and must be used by the winning couple as originally planned. If the couple is unable to proceed with the wedding for any reason, including but not limited to a breakup, change of wedding date, death, deployment, health-related issues, or any other unforeseen circumstances, the prize will be considered null and void. No cash alternative, substitutions, or rescheduling accommodations will be provided.
- Wed&Done reserves the right to revoke the prize if the couple is unable to fulfill the requirements necessary to redeem the package within the designated timeline.

Prize Cancellation Policy

- Once the winning couple accepts the prize and planning begins, funds will be allocated toward securing the wedding venue, vendors, and other planning elements. If the couple cancels their wedding after accepting the prize, the following policies will apply:
- Non-Refundable Expenses – Any funds already paid toward venue deposits, vendor retainers, or other services are non-refundable and non-transferable.
- Forfeiture of Remaining Prize Funds – Any unspent portion of the prize will be forfeited, and the wedding package will become null and void. No additional funds, credits, or compensation will be provided.
- Venue & Vendor Contract Responsibility – If the couple cancels, Wed&Done is not responsible for any outstanding costs owed to vendors or venues. Any payments beyond the allocated prize amount will be the couple's responsibility.
- Reallocation of Funds – Wed&Done reserves the right to reallocate remaining prize funds toward another couple or future contest at its discretion.
- Cancellation Notice Requirement – The couple must provide written notice of cancellation to Wed&Done as soon as possible. Failure to do so may result in additional charges if vendors require final payments.

- Travel, accommodations, and vendor gratuity **are not included**. Due to Arizona State Liquor Laws, bar services and alcohol for the wedding **are not included**.
 - The winner may be required to appear in promotional material, including video and social media content.

7. Legal & Tax Considerations

- The winner is responsible for **any taxes associated with the prize**. A **1099-MISC form** may be issued for the fair market value of the wedding package.
 - Contest is void where prohibited by law.
 - **Wed&Done is not liable** for unforeseen changes to the prize package due to venue availability.
 - This contest is registered with the **Arizona Attorney General's Office** per state requirements.

8. Publicity & Rights

By entering, participants grant **Wed&Done** the right to use their submission, name, and likeness for promotional purposes, including but not limited to advertising, press releases, and social media.

9. Cancellation & Refund Policy

- **Refunds:** The entry fee is **non-refundable** unless the contest is canceled.
- **Contest Cancellation:** If Wed&Done cancels the contest due to unforeseen circumstances, all entry fees will be refunded.
